Hockey memberships allow access to daily open member hockey ice times which are generally three hours per day.

Guest policy: Without prior written approval only members are allowed on the ice during open membership skating times.

Equipment: Proper protective equipment necessary (helmet, for hockey) and minors must be accompanied by an adult.

I agree that:

1. **Agreement** This is a legally binding agreement between Can-Am Ice Group, LLC, The Lil Rink ("the Rink"), the other members and I. I accept and agree to the fee schedule and membership benefits as more fully set forth herein and as set forth in the document attached hereto as Exhibit A and fully incorporated herein by reference.

2. **Guests** I understand and agree that as a member I am not permitted to bring guests (other than spectators) to the Rink to use the Rink or any of its facilities in any manner whatsoever without the express written permission of the Rink owners or managers and only after such guests have executed the proper Release and Waiver. I further agree that I am not permitted to charge any fee or cost whatsoever for use of the Rink by any person without the express written permission of the Rink owners or managers.

3. **Laws** I will be bound by the Rink's and its owners' rules and regulations. During the time I am a member of the club, I will also be bound by the laws, rules, regulations and guidelines of the relevant hockey organizations, including USA Hockey and US Figure Skating. I agree to participate in accordance with such rules, regulations and guidelines and all other applicable rules, regulations and directives and failure to do so will result in immediate termination.

4. **Terms of Membership** I acknowledge that if I;

a. do anything which may adversely affect or reflect on or discredit the Game of Hockey, the membership or the Rink, as may be defined solely at the discretion of Rink management or ownership;

b. breach any Rules of the Rink relating to foul play or misconduct,

c. assault, abuse, threaten or intimidate any other member of the Rink whether on or off the ice;

d. do not pay my membership or other fees when they become due and owing; or

e. do anything else that, in the sole and exclusive opinion of the Rink management or ownership requires the termination of my membership;

f. upon termination of my membership at anytime, I understand and agree that I am not entitled to any refund of money or dues whatsoever. Any failure to terminate by the Rink shall in no way be deemed a waiver of the Rink's right to terminate.

5. **Acknowledgment** I am aware and acknowledge that;

a. "Participate" means participating in any capacity in any event that has a connection with the Rink. This can include, but is not limited to, being involved in ice skating, games, trainings, social, fundraising or any other event in anyway associated with the Rink as a player, spectator, official or in any other capacity.

b. Participating in hockey has inherent dangers and risks, including risk of injury or death; and

c. Accidents can and often will happen which may result in me being injured or my property being damaged.

6. **Use of the Rink** I understand and agree that Rink reserves the exclusive and sole right to set times, dates and conditions for use of the Rink by members and nonmembers at its discretion. Such times, dates and conditions are subject to immediate change without prior notice to me. I agree to abide by any limits or restrictions on the use of the ice for specific purposes (for example exclusive hockey or figure skating times) during times, dates and conditions set by the Rink.

7. **Release and Indemnity** To the extent permitted by law, I release and indemnify the Rink, Can-

Am Ice Group, LLC, its owners, members, employees, agents and assigns and the Rink members from any claim that may arise due to my participation in any manner associated with the Rink. I participate at my own risk with a full appreciation of the nature and extent of all risks involved in the activity and accept and assume the risks in participating.

8. Payment of Fees I agree to pay my membership fees, playing fees and any other fees that are incurred by me in my participation ("fees"), as and when they become due and payable. I acknowledge and agree that if I do not pay my fees, then;

- a. The club may charge me interest at 10% per annum on any fees that remain outstanding from the date they became due and payable;
- b. I will not be allowed to participate until my fees have been paid;
- c. The Rink may charge me any costs it incurs in attempting to obtain those outstanding fees from me, including all administration and legal costs; and
- d. The Rink may terminate my membership.

9. Severance If any provisions of this membership agreement are invalid or unenforceable, then the offending phrase or clause will be read down or severed from this agreement so that this agreement may remain valid and enforceable.

10. Declaration I declare that;

- a. I have read, understood and agree to be bound by the terms of this agreement; and
- b. The information supplied by me on this application and agreement is true and correct
